7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a State Fiscal Year 2013 RECLAIM Ohio Grant, in the projected amount of**
9 **\$4,499,378.00, with no local cash match requirement, from the Ohio Department of Youth**
10 **Services, for the period 7/1/12 through 6/30/13, and appropriating \$4,499,378.00 in state**
11 **funding, for expenditures through 12/31/12, for the Court of Common Pleas - Juvenile**
12 **Court Division, and declaring an emergency.**

14 WHEREAS, RECLAIM Ohio is an initiative developed in 1993 to address the State's
15 overburdened juvenile justice system and allows local courts to target specific areas to help
16 divert youth from being institutionalized; and

18 WHEREAS, the County of Summit Juvenile Court has been awarded a State Fiscal Year
19 ("SFY") 2013 RECLAIM Ohio Grant (Juvenile Delinquent Care and Custody) from the Ohio
20 Department of Youth Services, which has estimated the annual award of \$4,499,378.00, for the
21 period 7/1/12 through 6/30/13, with no local cash match requirement; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
25 execute any documents necessary to accept the award of the aforementioned grant from the Ohio
26 Department of Youth Services for SFY 2013, and to appropriate grant funds;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:
