7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with E.L. Robinson Engineering for the first set of 24 bridges and one fracture**
9 **critical members inspection for the bridge load rating project round four, the first of two**
10 **awards for this project, in an amount not to exceed \$52,304.00, for the Engineer, and**
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 23, 2012, awarded a
14 professional service contract with E.L. Robinson Engineering for the first set of 24 bridges and
15 one fracture critical members inspection for the bridge load rating project round four, the first of
16 two awards for this project, subject to confirmation by County Council; and,

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a professional service contract with E.L. Robinson
27 Engineering for the first set of 24 bridges and one fracture critical members inspection for the
28 bridge load rating project round four, the first of two awards for this project, in an amount not to
29 exceed \$52,304.00, is hereby confirmed and the County Executive is hereby authorized to
30 execute such contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for the bridge load rating inspections.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,
