7 **A Resolution adopting the classification, classification specification and salary schedule for**
8 **the exempt unclassified position of Law Clerk # 50070 at the County Prosecutor's Office,**
9 **for the Executive's Department of Human Resources and the Prosecutor, and declaring an**
10 **emergency.**

12 WHEREAS, County Council has the authority pursuant to Article III, Section 3.03(10) of
13 the Charter of the County of Summit and Sections 169.08, 169.09, 169.10, and 169.11 of the
14 Codified Ordinances of the County of Summit, to establish classifications, classification
15 specifications and pay/salary schedules for all County employees; and

16
17 WHEREAS, the County Prosecutor requests that the classification, classification
18 specification and salary schedule for the exempt unclassified position of Law Clerk # 50070 at
19 the County Prosecutor's Office be approved by this Council because the current position of Law
20 Clerk is designated as classified, which is not proper for a legal position; and

21
22 WHEREAS, at its May 23, 2012 meeting, the County Human Resource Commission
23 ("HRC") approved the change in designation to exempt unclassified for the aforementioned
24 position at the County Prosecutor's Office and issued HRC Order 12-01 stating the same, which
25 is attached hereto as Exhibit C and incorporated herein as if fully restated;

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to adopt the classification,
29 classification specification and salary schedule for the exempt unclassified position of Law Clerk
30 # 50070 at the County Prosecutor's Office;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that;

37 The classification for Law Clerk # 50070 at the County Prosecutor's Office is hereby
38 approved, designated as exempt unclassified and assigned the salary schedule set forth in Exhibit
39 A, which is attached hereto and incorporated herein as if fully restated.

43 The classification specification for the exempt unclassified position of Law Clerk #
44 50070 at the County Prosecutor's Office, which is attached hereto respectively as Exhibit B and
45 incorporated herein as if fully restated, is hereby approved.

10 Prosecutor to begin using the classification.

14 Provided this Resolution receives the affirmative vote of eight members, it shall take
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
16 effect and be in force at the earliest time provided by law.

21 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
22 deliberations of this Council and any of its committees that resulted in such formal action, were
