7 **A Resolution appropriating federal Temporary Assistance to Needy Families funds from**
 8 **the Summit County Department of Job and Family Services in a total amount of**
 9 **\$736,680.00 for the Youth Employment for Success 2012 Summer Youth Employment**
 10 **Program, for the period 5/15/12 through 8/31/12, for the Executive’s Department of**
 11 **Communications, and declaring an emergency.**

 13 WHEREAS, Summit County Department of Job and Family Services (“County DJFS”)
 14 has been awarded Temporary Assistance to Needy Families (“TANF”) funds from the Ohio
 15 Department of Jobs and Family Services; and

 17 WHEREAS, Summit DJFS has awarded \$736,680.00 of the TANF funds to the County
 18 Executive’s Department of Communications’ Youth Employment for Success (“YES”) for a
 19 2012 Summer Youth Employment Program, as approved by this Council pursuant to Resolution
 20 No. 2012-217 and

 22 WHEREAS, YES was awarded the TANF funds to act as payroll agent for approximately
 23 440 youths and to administer the same during the period of May 15, 2012 to August 31, 2012;

 26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
 27 that it is necessary and in the best interest of the County to appropriate the aforementioned funds
 28 in the amount of \$736,680.00 for the YES 2012 Summer Youth Employment Program.


