7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Prosecutor to hire**
9 **one external person into a part-time, classified Secretary I position in the Prosecutor's**
10 **Office to fill a vacant position, working 34 hours per week at a rate of \$10.95 per hour, the**
11 **minimum pay rate for the position, for the Prosecutor, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Ordinance No. 2009-110, which enacted
14 Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled, "Temporary
15 Hiring Freeze," to control and reduce the County's budget deficit and Ordinance No. 2011-204,
16 which reinstated the hiring freeze through December 31, 2012; and

17
18 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
19 the filling of an existing position by hiring an employee is necessary for the effective and
20 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
21 said employees; and

23 WHEREAS, the County Prosecutor says it is necessary for the continued and effective
24 operation of her office to be permitted to hire and fill one part-time, classified Secretary I
25 position to fill a vacant position; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to authorize the County
29 Prosecutor to hire one external person into a part-time, classified Secretary I position in the
30 Prosecutor's Office to fill a vacant position, working 34 hours per week at a rate of \$10.95 per
31 hour, the minimum pay rate for the position;

33 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
34 State of Ohio, that:

38 County Council hereby determines that the County Prosecutor has demonstrated that it is
39 necessary for the effective and continued operation of her office to authorize the County
40 Prosecutor, pursuant to Section 169.04(j) of the Codified Ordinance, to hire one external person
41 into a part-time, classified Secretary I position in the Prosecutor's Office to fill a vacant position,
42 working 34 hours per week at a rate of \$10.95 per hour, the minimum pay rate for the position.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the citizens of the County of Summit and for the further reason to immediately
48 authorize the County Prosecutor to hire one part-time, classified Secretary I position in order to
49 continue effectively prosecuting cases and collect revenue for Summit County.


