7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled, "Temporary Hiring Freeze," to authorize the County Prosecutor to hire**
9 **one external person into a full-time non-bargaining unit Administrative Secretary position**
10 **in the Child Support Enforcement Agency of the Prosecutor's Office to fill a vacant**
11 **position, at a rate of \$14.29 per hour, for the Prosecutor, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Ordinance No. 2009-110, which enacted
14 Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled, "Temporary
15 Hiring Freeze," to control and reduce the County's budget deficit and Ordinance No. 2011-204,
16 which reinstated the hiring freeze through December 31, 2012; and

17
18 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
19 the filling of an existing position by hiring an employee is necessary for the effective and
20 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
21 said employees; and

23 WHEREAS, the Prosecutor says it is necessary for the continued and effective operation
24 of her Child Support Enforcement Agency to be permitted to hire one external person into a full-
25 time, non-bargaining unit Administrative Secretary position; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to authorize the Prosecutor to
29 hire one external person into a full-time, non-bargaining unit Administrative Secretary position
30 at the rate of \$14.29 per hour;

32 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
33 State of Ohio, that:

37 County Council hereby determines that the County Prosecutor has demonstrated that it is
38 necessary for the effective and continued operation of her office to authorize the Prosecutor,
39 pursuant to Section 169.04(j) of the Codified Ordinance, to hire one external person into a full-
40 time, non-bargaining unit Administrative Secretary position at the rate of \$14.29 per hour.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the citizens of the County of Summit and for the further reason to immediately
46 authorize the Prosecutor to hire one external person into a full-time, non-bargaining unit
47 Administrative Secretary position in order to continue effectively establishing and enforcing
48 child support orders and collecting support for families in Summit County.
