7 **A Resolution confirming the award by the Board of Control of a three-year professional**  
8 **service contract with LexisNexis, as Best Practical Source, to provide on-line legal research**  
9 **services for the Law Library Resources Board in its operation of the Law Library, for the**  
10 **period 12/1/12 through 11/30/15, for the amount of \$2,446.00/mo. or \$29,352.00 from**  
11 **12/1/12 through 11/30/13, \$2,519.00/mo. or \$30,228.00 for 12/1/13 through 11/30/14 and**  
12 **\$2,595.00 or \$31,140.00 for 12/1/14 through 11/30/15, for a total amount not to exceed**  
13 **\$90,720.00, for the Law Library Resources Board, and declaring an emergency.**

15 WHEREAS, the Akron Law Library Association previously operated the Law Library,  
16 located on the fourth floor of the County of Summit Courthouse; and

17  
18 WHEREAS, the Ohio General Assembly enacted 2008 Amended Substitute Ohio House  
19 Bill 420, which established county law library resource boards to operate law libraries; and

20  
21 WHEREAS, the County of Summit Law Library Resources Board took over operation of  
22 the Law Library on 1/1/10; and

23  
24 WHEREAS, as part of its operation, it is necessary for the Board to purchase a contract  
25 for on-line legal research services; and

26  
27 WHEREAS, at its October 25, 2012 meeting, the Law Library Resources Board approved  
28 a three-year professional service contract with LexisNexis to provide on-line legal research  
29 services for the Law Library Resources Board in its operation of the Law Library, for the period  
30 12/1/12 through 11/30/15, for the amount of \$2,446.00/mo. or \$29,352.00 from 12/1/12 through  
31 11/30/13, \$2,519.00/mo. or \$30,228.00 for 12/1/13 through 11/30/14 and \$2,595.00 or  
32 \$31,140.00 for 12/1/14 through 11/30/15, for a total amount not to exceed \$90,720.00; and

34 WHEREAS, at its November 14, 2012 meeting, the Board of Control awarded the  
35 aforementioned professional service contract with LexisNexis, as Best Practical Source, subject  
36 to the approval of County Council; and

37  
38 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
39 that it is necessary and in the best interest of the County of Summit to confirm the award of the  
40 of the aforementioned professional service contract with LexisNexis;

42 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,

47 The award by the Board of Control of a three-year professional service contract with

7 execute said contract.

9 SECTION 2

11 This Resolution is hereby declared to be an emergency in the interest of the health,  
12 safety, and welfare of the citizens of the County of Summit, and for the further reason to  
13 immediately authorize the Executive to execute the first amendment and renewal of a necessary  
14 professional service contract with LexisNexis to provide on-line legal research services for the  
15 Law Library Resources Board in its operation of the Law Library in 2013-2015.

17 SECTION 3

19 Provided this Resolution receives the affirmative vote of eight members, it shall take  
20 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
21 effect and be in force at the earliest time provided by law.
