7 **A Resolution approving a salary adjustment for classified non-bargaining employee**  
8 **Rebecca Stock, as a result of the assumption of additional duties due to attrition, for the**  
9 **Prosecutor's Child Support Enforcement Agency, and declaring an emergency.**

11 WHEREAS, the Prosecutor wishes to grant a salary adjustment for classified non-  
12 bargaining employee Rebecca Stock based on the assumption of additional duties as a result of  
13 not replacing certain positions due to attrition, and due to job performance and pay equity; and

15 WHEREAS, because a salary adjustment for the aforementioned employee represents a  
16 pay increase under Section 169.07 of the Codified Ordinances of the County of Summit, County  
17 Council's approval is required; and

19 WHEREAS, the Director of the Department of Human Resources will review the  
20 personnel action for the aforementioned salary adjustment as required by Section 169.07(b) of  
21 the Codified Ordinances of the County of Summit; and

23 WHEREAS, the salary adjustment will be submitted to the Director of the Department of  
24 Finance and Budget for the certification of availability of appropriated funds, as required by  
25 Section 169.07(b) of the Codified Ordinances of the County of Summit; and

27 WHEREAS, this Council has determined, after reviewing all pertinent information, that  
28 the aforementioned salary adjustment is necessary and in the best interest of the County of  
29 Summit;

31 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,

16 121.22 of the Ohio Revised Code.


