7 **A Resolution appropriating grant funds in the amount of \$200,552.28 in carryover**
8 **balances for 2013 in various grants, for the Sheriff, and declaring an emergency.**

10 WHEREAS, the County Sheriff's office has three grants from the Ohio Department of
11 Public Safety/Ohio Traffic Safety Office with carryover balances and end dates of 9/30/13,
12 including \$83,020.32 in the Operating Vehicle Intoxicated ("OVI") grant, \$10,296.00 in the Law
13 Enforcement Liaison ("LEL") grant and \$69,179.90 in the High Visibility Enforcement
14 Overtime ("HVEO") grant; and

16 WHEREAS, the Sheriff's office has a carryover balance of \$38,056.06 in a Drug Unit
17 grant from the Ohio Department of Public Safety/Office of Criminal Justice with an end date of
18 1/31/13; and

20 WHEREAS, it is necessary to appropriate these carryover balances from 2012 for 2013
21 operations; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that the aforementioned carryover appropriations in the amount of \$200,552.28 are necessary and
25 in the best interest of the County of Summit,
