7 **A Resolution appropriating carryover funds for the Juvenile Court Clerk Fees Fund in the**

11 WHEREAS, the Internal Revenue Service ("IRS") issued Regulation 6045, concerning
12 the requirement to issue an IRS form 1099, to report annual gross payments to an attorney for the
13 payment of legal services aggregating \$600.00 or more in a calendar year; and

15 WHEREAS, in a 2012 review of this IRS Regulation, it is the consensus of the County of
16 Summit Department of Internal Audit, Fiscal Office and Juvenile Court that the Juvenile Court
17 should establish a new fund in the amount of \$10,000.00 from which to record fee payments, and
18 this amount is available for carryover to fiscal year 2013; and

20 WHEREAS, the Juvenile Court Clerk Fees fund allows the Juvenile Court to pay attorney
21 services costs and provide the necessary documentation for compliance with IRS regulation
22 6045; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to appropriate the
26 aforementioned carryover funds, in the amount of \$10,000.00;
