7 **A Resolution confirming an award by the Board of Control of a purchase order with the**
8 **City of Akron for maintenance costs required by the Interlocal Agreement for the 800 MHz**
9 **Regional Radio System, for Fiscal Year 2013, in an amount not to exceed \$60,000.00, for**
10 **the Executive's Department of Law, Insurance and Risk Management – Division of Public**
11 **Safety, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held 1/9/13, awarded a purchase order
14 with the City of Akron for maintenance costs required by the Interlocal Agreement for the 800
15 MHz Regional Radio System, for Fiscal Year 2013, subject to confirmation by County Council;

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that it is necessary and in the best interest of the County of Summit to confirm the award by the
20 Board of Control for the aforementioned purchase order;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
23 of Ohio, that:

25 SECTION 1

27 The award by the Board of Control of a purchase order with the City of Akron for
28 maintenance costs required by the Interlocal Agreement for the 800 MHz Regional Radio
29 System, for Fiscal Year 2013, in an amount not to exceed \$60,000.00, is hereby confirmed and
30 the County Executive is hereby authorized to execute such purchase order.

32 SECTION 2

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further purpose to immediately
36 provide public safety radio system services for Fiscal Year 2013.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,
49 were in meetings open to the public, in compliance with all legal requirements, including Section
50 121.22 of the Ohio Revised Code.
