13 purchase order with various vendors per attached Exhibit A for snow and ice removal materials,
14 under CUE pricing, subject to confirmation by County Council; and

17 that the purchase order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

25 Exhibit A for snow and ice removal materials, under CUE pricing, in a total amount not to
26 exceed \$845,000.00, is hereby confirmed and the County Executive is hereby authorized to

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide snow and ice removal materials in 2013.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.
