7 **A Resolution accepting and approving a resubdivision titled "McKnight Park Subdivision**
8 **Replat No. 2," located in Springfield Township, Council District 8, for the Executive-**
9 **Planning Commission and the Engineer, and declaring an emergency.**

11 WHEREAS, on February 4, 2013, the County of Summit Planning Commission
12 administratively approved a resubdivision titled "McKnight Park Subdivision Replat No. 2,"
13 concerning a subdivision located in Springfield Township; and

15 WHEREAS, under Section 1104.06 (b) (4) of the Codified Ordinances of the County of
16 Summit and Section 711.041 of the Ohio Revised Code, the approval of this Council is a
17 prerequisite for the recording of a resubdivision of a previously recorded plat, as though the same
18 were a major subdivision; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the acceptance and approval of the aforementioned replat is necessary and in the best interest
22 of the County of Summit;

24 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State
25 of Ohio, that;

27 SECTION 1

29 The resubdivision, together with restrictions, covenants, and easements thereon, is hereby
30 accepted by the County of Summit, to be recorded by the County Fiscal Officer. The affected
31 property shall remain a part of the McKnight Park Subdivision, as shown by the recorded
32 document titled "McKnight Park Subdivision Replat No. 2," located in Springfield Township,
33 Council District 8.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the citizens of the County of Summit, and for the further reason that it immediately
39 facilitates development in Springfield Township.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.
