12 WHEREAS, the County of Summit Juvenile Court receives donations from the County of
13 Summit Juvenile Court's Women's Board and other charitable organizations, with no local cash
14 match requirement, for the period 1/1/13 through 12/31/13; and

16 WHEREAS, the Juvenile Court wishes to establish a fund for these donated monies and
17 appropriate the sum of \$50,000.00, which will be used to help improve the lives of youth under
18 the care of the Juvenile Court, as well as supporting many of the Court's special programs and
19 events; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit to appropriate the
23 aforementioned funds in the total amount of \$50,000.00, with no local cash match requirement;
