7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Ward & Associates to perform valuation of commercial, industrial and**
9 **exempt buildings considered to be new or altered in construction in Summit County, with**
10 **all work to be completed by July 31, 2013, in an amount not to exceed \$57,200.00, for the**
11 **Fiscal Officer, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held February 20, 2013, awarded a
14 professional service contract with Ward & Associates to perform valuation of commercial,
15 industrial and exempt buildings considered to be new or altered in construction in Summit
16 County, with all work to be completed by July 31, 2013, subject to confirmation by County
17 Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that the contract is necessary and in the best interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
23 of Ohio, that:

27 The award by the Board of Control of a professional service contract for an
28 intergovernmental agreement with Ward & Associates to perform valuation of commercial,
29 industrial and exempt buildings considered to be new or altered in construction in Summit
30 County, with all work to be completed by July 31, 2013, in an amount not to exceed \$57,200.00,
31 is hereby confirmed and the County Executive is hereby authorized to execute such contract.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of the County of Summit, and for the further reason to immediately
37 provide for valuation services.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
49 deliberations of this Council and of any of its committees that resulted in such formal action,

51 121.22 of the Ohio Revised Code.
