A Resolution accepting and approving a subdivision titled Barn Hill Subdivision No. 3, located in Bath Township, Council District 5, for the Executive-Planning Commission and the County Engineer, and declaring an emergency.

WHEREAS, on March 31, 2011, the Planning Commission approved a subdivision titled "Barn Hill Subdivision No. 3", located in Bath Township; and

WHEREAS, under Section 1104.06 (b) (4) of the Codified Ordinances of the County of Summit and Section 711.041 of the Ohio Revised Code, the approval of this Council is a prerequisite for the recording of said plat; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the acceptance and approval of the aforementioned plat is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

SECTION 1

The subdivision, together with restrictions, covenants, and easements thereon, is hereby accepted by the County of Summit, to be recorded by the County Fiscal Officer. The subdivision shall be known as Barn Hill Subdivision No. 3, and is located in Bath Township, Council District 5.

SECTION 2

The following maintenance bond furnished by Ohio Farmers Insurance Company in the amount of \$13,219.00, having been submitted and approved, was accepted in conjunction with the Barn Hill Subdivision No. 3. The documents are to be retained by the County Executive, who is authorized to release said bond, in part or in full, upon satisfactory completion of the obligations set forth.

SECTION 3

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason that it immediately facilitates development in Bath Township.

SECTION 4

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
