An <u>amended</u> Ordinance amending Sections 169.07, 169.08, 169.15, 169.22 and 169.28 of the Codified Ordinances of the County of Summit, for the Executive's Department of Human Resources, and declaring an emergency.

WHEREAS, representatives from County offices have made certain recommendations for revisions to Chapter 169 of the Codified Ordinances of the County of Summit, entitled "Personnel Policies and Procedures;" and

WHEREAS, said recommendations have been reviewed and approved by the Executive's Department of Human Resources; and

WHEREAS, on February 4, 2013, the Human Resource Commission adopted Order No. 13-01, approving the recommended revisions to Chapter 169; and

WHEREAS, having reviewed the same, this Council has elected to adopt certain of the revisions, specifically amendments to Section 169.15, 169.22 and 169.28 of the Codified Ordinances of the County of Summit, and will consider the balance of the recommendations at a later date; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to adopt said recommendation and amend Sections 169.07, 169.08, 169.15, 169.22 and 169.28 of the Codified Ordinances of the County of Summit;

NOW, THEREFORE, BE IT ORDNAINED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Sections 169.07, 169.08, 169.15, 169.22 and 169.28 of the Codified Ordinances of the County of Summit are hereby amended as set forth in <u>Amended</u> Exhibit A, attached hereto and incorporated herein by reference.

SECTION 2

The Ordinance is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason of immediately amending Chapter 169 in order to immediately implement a more efficient human resource system in the County.

SECTION 3
