7 **A Resolution confirming an award by the Board of Control of a month-to-month lease with**
8 **Bridgestone Firestone for 4,250 square feet of office space for the Drug Unit Task Force,**
9 **for the period 1/1/13 through 12/31/13, as Best Practical Source, in an amount not to exceed**
10 **\$3,276.25 per month, for a total amount not to exceed \$39,315.00, for the Sheriff, and**
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held March 20, 2013, awarded a month-
14 to-month lease with Bridgestone Firestone for 4,250 square feet of office space for the Drug Unit
15 Task Force, for the period 1/1/13 through 12/31/13, as Best Practical Source, subject to
16 confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the lease is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a month-to-month lease with Bridgestone Firestone
27 for 4,250 square feet of office space for the Drug Unit Task Force, for the period 1/1/13 through
28 12/31/13, as Best Practical Source, in an amount not to exceed \$3,276.25 per month, for a total
29 amount not to exceed \$39,315.00, is hereby confirmed and the County Executive is hereby
30 authorized to execute such lease.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for office space for the Drug Unit Task Force in 2013.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,
