A Resolution authorizing the County Executive to execute any documents necessary to accept an award from the Ohio Department of Rehabilitation and Corrections for a Community Based Correctional Facility subsidy grant, in the amount of \$14,560.00, with no local cash match requirement, and to execute an addendum to the contract with Oriana House, Inc., for the grant operations, and appropriating these additional funds in the amount of \$14,560.00 for the grant expenditures, for the state fiscal year ending 6/30/13, for the Executive's Department of Law, Insurance and Risk Management - Division of Public Safety, and declaring an emergency.

WHEREAS, the Ohio Department of Rehabilitation and Corrections ("ODRC") has awarded a subsidy grant of \$14,560.00 as additional funding, for a total not to exceed \$4,804,560.00, to support the Community Based Correctional Facility ("CBCF") program, for the state fiscal year ending 6/30/13 ("SFY13"); and

WHEREAS, the Summit County Facility Governing Board, the grant's statutory oversight committee, has selected Oriana House, Inc., as the vendor to continue the management of the facility's operations and to receive this additional funding, and

WHEREAS, the County of Summit will continue to be the fiscal agent for the program, and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to accept the award of the aforementioned grant from ODRC, to execute an addendum to the contract with Oriana House, Inc., and to appropriate these grant funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute any documents necessary to accept the award of additional state fiscal year 2013 ("SFY13") Community Based Correctional Facility ("CBCF") funds from the Ohio Department of Rehabilitation and Corrections ("ODRC"), for the state fiscal year ending 6/30/13, in the amount of \$14,560.00, with no local cash match requirement.
