SECTION 3 (cont'd.)

A renewal of a tax for the benefit of the County of Summit, Ohio for the purpose of operating and capital expenses for the provision and maintenance of zoological park services and facilities at the Akron Zoo at a rate not exceeding eight-tenths (0.8) mill for each one dollar of valuation, which amounts to eight cents (\$0.08) for each one hundred dollars of valuation, for a period of seven years.

SECTION 4

Board of Elections Filing. This Council authorizes and directs the Clerk of this Council to file with the Summit County Board of Elections, not later than August 7, 2013, a copy of this Resolution, a copy of the Resolution of Necessity, and a copy of the County Fiscal Officer's certification. This Council requests the Board of Elections to prepare the ballots and make other necessary arrangements for the submission of this question to the electors of Summit County, all in accordance with law.

SECTION 5

Statement of Emergency. This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the County, and for the further reason that this resolution is required to be immediately effective to certify the question to the Board of Elections in time for the November 5, 2013 election.

SECTION 6

Effective Date. Provided this Resolution receives the affirmative vote of eight members, it will take effect immediately upon its adoption and approval by the County Executive; otherwise, it will take effect and be in force at the earliest time provided by law.

SECTION 7

Open Meetings. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with legal requirements, including Section 121.22 of the Ohio Revised Code.
