7 **A Resolution authorizing the County Executive to execute an Intergovernmental**
8 **Agreement with Summit County Combined General Health District to utilize the County's**
9 **on-line recruitment system for open employment positions through a third-party vendor,**
10 **NEOGOV, for which the Health District shall pay the County \$2,141.51 annually, for the**
11 **Executive, and declaring an emergency.**

13 WHEREAS, the County maintains and operates an on-line recruitment system for open
14 employment positions within the County through a third party vendor, NEOGOV ("On-Line
15 Recruitment System"); and

16
17 WHEREAS, Summit County Combined General Health District ("Health District")
18 wishes to utilize the On-Line Recruitment System to conduct on-line recruitment for open
19 employment positions and has agreed to pay the County \$2,141.51 annually for such access; and

21 WHEREAS, it is necessary for the parties to execute an Intergovernmental Agreement to
22 set forth the rights and duties of the parties concerning the provision of access to the On-Line
23 Recruitment System by the Health District; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to authorize the County
27 Executive to execute an Intergovernmental Agreement with the Health District for the
28 aforementioned purposes, for which the Health District shall pay the County \$2,141.51 annually;

30 NOW, THEREFORE, IT IS HEREBY RESOLVED by the Council of the County of
31 Summit, State of Ohio, that:

33 SECTION 1

35 The County Executive is hereby authorized to execute an Intergovernmental Agreement
36 with Summit County Combined General Health District ("Health District) to utilize the County's
37 on-line recruitment system for open employment positions through a third-party vendor,
38 NEOGOV ("On-Line Recruitment System"), for which the Health District shall pay the County
39 \$2,141.51 annually.

43 This Resolution is hereby declared to be an emergency in the interest of the health, safety
44 and welfare of the citizens of the County of Summit, Ohio, and for the further reason that it is
45 necessary in order to immediately provide access to the On-Line Recruitment System by the
46 General Health District.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
52 effect and be in force at the earliest time provided by law.
