7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the Violence Against Women Act grant award from the Ohio Office of Public**
9 **Safety/Office of Criminal Justice Services, for the period 1/1/13 through 12/31/13, in the**
10 **amount of \$35,550.31 in federal funding, with a 25% local cash requirement of \$11,850.10,**
11 **for a grant total of \$47,400.41, and appropriating supplemental funds of \$8,234.37, for a**
12 **total program appropriation of \$55,634.78, for the Prosecutor, and declaring an**
13 **emergency.**

14
15 WHEREAS, the Ohio Office of Public Safety/Office of Criminal Justice Services
16 (“OCJS”), has awarded the County Prosecutor a Violence Against Women Act (“VAWA”)
17 grant of federal funds, in the amount of \$35,550.31, which requires a 25% local cash match
18 requirement of \$11,850.10, for the period 1/1/13 through 12/31/13; and

20 WHEREAS, the grant award totaling \$47,400.41 reflects budget reductions by the federal
21 budget and will require an additional funding match in the amount of \$8,234.37, for a total
22 program operating budget of \$55,634.78; and

24 WHEREAS, the full match funding has been provided for with appropriations within the
25 Prosecutor’s 2013 operating budget approved in Resolution No. 2012-475; and

27 WHEREAS, this VAWA program funding supports a victim advocate position, in order
28 to provide the mandated services to victims of crime; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
32 execute any documents necessary to accept the awards of the aforementioned grants from OCJS,
33 and to appropriate these grant funds;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
36 of Ohio, that:

40 The County Executive is hereby authorized to execute any documents necessary to accept
41 the Violence Against Women Act (“VAWA”) grant award, from the Ohio Office of Public
42 Safety/Office of Criminal Justice Services (“OCJS”), for the period 1/1/13 through 12/31/13, in
43 the amount of \$55,634.78, including \$35,550.31 in grant funding, and requiring \$20,084.47 in
44 local cash match requirements.
