A Resolution authorizing the County Executive to execute any documents necessary to accept a Court Appointed Special Advocates program grant, from the Summit County Court Appointed Special Advocate Volunteer Board Association, Inc., in the amount of \$36,124.50, with no local cash match requirement, for the period 7/1/13 to 6/30/14, and appropriating these funds, for the Court of Common Pleas - Juvenile Division, and declaring an emergency.

WHEREAS, the Summit County Court Appointed Special Advocate ("CASA") Volunteer Board Association, Inc. ("CASA Board"), has awarded the County of Summit Court of Common Pleas - Juvenile Division, a CASA program grant, in the amount of \$35,000.00, with no local cash match requirement, for the period 7/1/13 to 6/30/14; and

WHEREAS, the CASA Board has awarded the Court of Common Pleas - Juvenile Division, an additional CASA program grant, in the amount of \$1,124.50, for a total award of \$36,124.50, in order to fund one full-time volunteer coordinator position, and one part-time volunteer training coordinator, for the period 7/1/13 to 6/30/14; and

WHEREAS, the CASA Board is a private 501(C)3 organization that helps recruit, retain and support CASA volunteers who advocate on behalf of abused and neglected children in Summit County; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to accept the award of the aforementioned grant from the Summit County CASA Volunteer Board Association, Inc.;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute any documents necessary to accept the award from the Summit County Court Appointed Special Advocate ("CASA") Volunteer Board Association, Inc., of a CASA program grant, for the period 7/1/13 to 6/30/14, to the County of Summit Court of Common Pleas - Juvenile Division, in the amount of \$36,124.50, with no local cash match requirement.
