A Resolution authorizing the County Executive to execute a renewal agreement with Oriana House, Inc., and the County of Summit Facility Governing Board, for the operation of the County's Community Based Correctional Facility, for a one-year term, for State Fiscal Year 2014, for the period 7/1/13 through 6/30/14, in an amount not to exceed \$4,790,000.00, which is funded through the State of Ohio's Community Based Correctional Facility subsidy grant, for the Executive's Department of Law, Insurance and Risk Management – Division of Public Safety and declaring an emergency.

WHEREAS, the State of Ohio Department of Rehabilitation has renewed the award to the County of Summit of a Community Based Correction Facility ("CBCF") subsidy grant, for the period 7/1/13 through 6/30/14, in the amount of \$4,790,000.00, with no local cash match requirement, for a Summit County CBCF to be operated by Oriana House, Inc.; and

WHEREAS, this Council previously adopted Resolution No. 2013-241, which authorized the County Executive to execute any documents necessary to accept the CBCF grant and appropriate grant funds; and

WHEREAS, it is necessary for this Council to authorize the Executive to execute a renewal agreement with Oriana House, Inc., and the County of Summit Facility Governing Board, for the operation of the County's CBCF for a one-year term, for State Fiscal Year ("SFY") 2014, for the period 7/1/13 through 6/30/14, in an amount not to exceed \$4,790,000.00, which is funded through the CBCF subsidy grant; and
