7 **A Resolution declaring it necessary to submit the question of the renewal of an existing tax**  
8 **levy to the electors of the County of Summit for the purpose of mental health and recovery**  
9 **programs for children, adults, and families for the Summit County service district, and for**  
10 **the acquisition, construction, renovation, financing, maintenance and operation of the**  
11 **County of Summit Alcohol, Drug Addiction and Mental Health Services Board facilities;**  
12 **requesting the Summit County Fiscal Officer to certify the total valuation of the County**  
13 **and the dollar amount of revenue that would be generated by that renewal levy, for the**  
14 **Executive, and declaring an emergency.**

15  
16 WHEREAS, this Council is the taxing authority of Summit County pursuant to Article  
17 III, Section 3.01 of the County Charter; and

18  
19 WHEREAS, the electors of Summit County, on November 6, 2007, approved the  
20 replacement of a portion of an existing 3.05 mill levy at a lesser rate of 2.95 mills for the purpose  
21 of mental health and recovery programs for children, adults, and families for the Summit County  
22 service district, and for the acquisition, construction, renovation, financing, maintenance and  
23 operation of the County of Summit Alcohol, Drug Addiction and Mental Health Services  
24 ("ADM") Board facilities; and

25  
26 WHEREAS, the amount of taxes which may be raised within the ten-mill limitation will  
27 be insufficient to provide for necessary requirements of the aforesaid purpose, and it is necessary  
28 to renew the levy of a tax in excess of such limitation pursuant to Section 5705.221 of the Ohio  
29 Revised Code; and

30  
31 WHEREAS, the County of Summit Social Services Advisory Board has recommended  
32 and requested that this Council place upon the ballot at the election on November 5, 2013, the  
33 question of the renewal of that existing levy, being a tax levy of 2.95 mills for the aforesaid  
34 purpose, to run for a period of six years, beginning with the 2014 tax list and duplicate, for  
35 collection in the years 2015 through 2020 inclusive; and

36  
37 WHEREAS, pursuant to Section 5705.03(B) of the Ohio Revised Code, it is necessary  
38 for the taxing authority to certify to the County Fiscal Officer a resolution requesting that the  
39 County Fiscal Officer certify to the taxing authority the total current tax valuation of Summit  
40 County and the dollar amount of the revenue that would be generated by the aforesaid renewal  
41 levy; and

43 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
44 that it is necessary and in the best interest of the County of Summit to declare the necessity of  
45 renewing the aforementioned tax levy of 2.95 mills for the County of Summit ADM Board and  
46 to certify this Resolution to the County Fiscal Officer requesting that she certify to the taxing  
47 authority the total current tax valuation of Summit County, and the dollar amount of revenue that  
48 would be generated by the aforesaid renewal levy;

50 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
51 State of Ohio, two-thirds of all the members elected thereto concurring, that:

4 SECTION 1

5  
6 It is necessary to renew the existing 2.95 mill tax levy in excess of the ten-mill limitation  
7 for a period of six years, commencing with the 2014 tax list and duplicate for collection in the  
8 years 2015 through 2020, inclusive, for the purpose of mental health and recovery programs for  
9 children, adults, and families for the Summit County service district, and for the acquisition,  
10 construction, renovation, financing, maintenance and operation of the County of Summit  
11 Alcohol, Drug Addiction and Mental Health Services ("ADM") Board facilities.  
12

13 SECTION 2

14  
15 In accordance with Section 5705.03(B) of the Ohio Revised Code, this Council  
16 authorizes and requests the Clerk of Council to certify a copy of this Resolution to the County  
17 Fiscal Officer for calculation of the total current tax valuation of Summit County, and the dollar  
18 amount of revenue that would be generated by the aforesaid renewal levy of 2.95 mills. This  
19 Council requests the County Fiscal Officer to thereupon certify to it both (i) the total current tax  
20 valuation of the County, and (ii) the dollar amount of revenue that would be generated by the  
21 aforesaid renewal levy of 2.95 mills.

23 SECTION 3

24  
25 This Resolution is hereby declared an emergency in the interest of the health, safety and  
26 welfare of the citizens of the County of Summit and for the further reason to timely certify to the  
27 Summit County Board of Elections this ballot issue.  
28

29 SECTION 4

30  
31 Provided that this Resolution receives the affirmative vote of eight members, it shall take  
32 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
33 effect and be force at the earliest time provided by law.

35 SECTION 5

37 It is found and determined that all formal actions of this Council concerning and relating  
38 the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
39 deliberations of this Council and any of its committees that resulted in such formal action, were  
40 in meetings open to the public, in compliance with all legal requirements, including Section  
41 121.22 of the Ohio Revised Code.
