**A Resolution appropriating funds for the Court of Common Pleas – Probate Division Mental Health fund, in the amount of \$60,000.00, for the fiscal period 2013, for the Court of Common Pleas - Probate Division, and declaring an emergency.**

WHEREAS, the Court of Common Pleas - Probate Division has jurisdiction over numerous probate activities including the responsibility for certain commitments of individuals to mental health state hospitals; and

WHEREAS, Summit County receives reimbursement funds from the State of Ohio for certain mental health expenses; and

WHEREAS, a separate mental health fund is required by Section 5122.43(B) of the Ohio Revised Code to pay all costs, fees and expenses for mental health services; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to appropriate the aforementioned funds in the total amount of \$60,000.00, with no local cash match requirement;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
