7 A Resolution authorizing the County Executive to execute any documents necessary to
8 accept an award of federal funds from the Ohio Department of Job and Family Services of
9 a State Fiscal Year 2014 Connecting the Dots Temporary Assistance for Needy Families
10 Demo grant, in the amount of \$250,556.00, with no local cash match requirement, and
11 appropriating the total for expenditures in calendar year 2013, for the Executive's
12 Department of Job and Family Services, and declaring an emergency.

14 WHEREAS, the County Executive's Department of Job and Family Services
15 ("SCDJFS") has received notification of a pending award of a State Fiscal Year 2014 ("SFY
16 2014") Connecting the Dots Temporary Assistance for Needy Families ("TANF") Demo grant
17 from the Ohio Department of Job and Family Services ("ODJFS") of federal funds in the amount
18 of \$250,556.00, with no local cash match requirement; and

20 WHEREAS, these funds will enable SCDJFS to operate a Connecting the Dots program
21 within SFY 2014, for the period 7/1/13 through 6/30/14, with the purpose of improving the
22 educational and employment outcomes for Summit County youth aging out of foster care and
23 supporting their transition to adulthood; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
27 execute any documents necessary to accept the award of the aforementioned grant from the
28 ODJFS and to appropriate these grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The County Executive is hereby authorized to execute any documents necessary to accept
36 the award of a State Fiscal Year 2014 ("SFY 2014") Connecting the Dots Temporary Assistance
37 for Needy Families ("TANF") Demo grant award from the Ohio Department of Job and Family
38 Services ("ODJFS"), for the period ending 6/30/14, in the amount of \$250,556.00, with no local
39 cash match requirement.


