7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with the County of Summit Fiscal Office for a IV-D provider contract to**
9 **reimburse the Fiscal Office for payment collection services and expenses related to Child**
10 **Support Enforcement Agency child support payments, for the period 7/1/13 through**
11 **6/30/14, in an amount not to exceed \$106,200.28, for the Prosecutor's Child Support**
12 **Enforcement Agency, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held June 12, 2013, awarded a
15 professional service contract with the County of Summit Fiscal Office for a IV-D provider
16 contract to reimburse the Fiscal Office for payment collections services and expenses related to
17 Child Support Enforcement Agency child support payments, for the period 7/1/13 through
18 6/30/14, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the contract is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that:

28 The award by the Board of Control of a professional service contract with the County of
29 Summit Fiscal Office for a IV-D provider contract to reimburse the Fiscal Office for payment
30 collection services and expenses related to Child Support Enforcement Agency child support
31 payments, for the period 7/1/13 through 6/30/14, in an amount not to exceed \$106,200.28, is
32 hereby confirmed and the County Executive is hereby authorized to execute such contract.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the citizens of the County of Summit, and for the further reason to immediately
38 provide for the reimbursements effective 7/1/13.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
50 deliberations of this Council and of any of its committees that resulted in such formal action,


