7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**
8 **Summit, ratifying purchases by the Court of Common Pleas – General Division in calendar**
9 **year 2013 from Sound Com Corporation for information technology hardware and**
10 **software, for a total aggregate amount not to exceed \$36,126.93, for calendar year 2013, for**
11 **the Court of Common Pleas – General Division, and declaring an emergency.**

13 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
14 requires that purchases by an officeholder exceeding \$25,000.00 in aggregate in any calendar
15 year, where no additional competitive quotes or bids have been taken, shall be made only upon
16 authorization of County Council; and

18 WHEREAS, the Department of Finance and Budget has previously approved purchases
19 by the Court of Common Pleas – General Division in calendar year 2013, per attached Exhibit A,
20 with Sound Com Corporation for information technology hardware and software; and

22 WHEREAS this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County to ratify purchases by the Court of
24 Common Pleas – General Division in calendar year 2013 from Sound Com Corporation for
25 information technology hardware and software, per attached Exhibit A, for a total aggregate
26 amount not to exceed \$36,126.93.

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State


