SECTION 3

This Council further directs that the Resolution of the Boston Township Board of Trustees approving the Contract be submitted to the electors of the Township for approval at the General Election to be held on November 5, 2013. The Clerk of Council is directed to file with the Summit County Board of Elections at least 75 days prior to that General Election a copy of this Resolution and a copy of the Resolution of the Boston Township Board of Trustees approving the Contract. The Summit County Board of Elections is hereby authorized and directed to conduct the election in the Township on November 5, 2013 in accordance with the Act. The ballot for that election shall be in the form provided in Section 715.71 (E) of the Ohio Revised Code.

SECTION 4

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit, and for the further reason to immediately adopt this Resolution in order to comply with the timing requirements of the Act and to timely submit the matter to the Summit County Board of Elections for the November 5, 2013 General Elections.

SECTION 5

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 6

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
