WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the acceptance and approval of the aforementioned replat is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State of Ohio, that;

# **SECTION 1**

The subdivision, together with restrictions, covenants, and easements thereon, is hereby accepted by the County of Summit, to be recorded by the County Fiscal Officer. The subdivision shall be known as the "Natures Preserve Phase 2," and is located in Twinsburg Township, Council District 1.

#### **SECTION 2**

The following performance and maintenance bonds furnished by American Contractors Indemnity Company in the amounts of \$84,570.00 and \$83,825.40, respectively, having been submitted and approved, was accepted in conjunction with the "Natures Preserve Phase 2." The documents are to be retained by the County Executive, who is authorized to release said bond, in part or in full, upon satisfactory completion of the obligations set forth.

### **SECTION 3**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason that it immediately facilitates development in Twinsburg Township.

# **SECTION 4**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
