A Resolution confirming an award by the Board of Control of a professional service contract with Wellness IQ, Inc., to provide vitality wellness services to and for the benefit of county employees, for a term of one year, from 11/1/13 through 10/31/14, at a cost of \$6.50 per employee per month, plus an initial setup fee of \$5,000.00, for a total amount not to exceed \$200,000.00, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, pursuant to Section 177.07(a)(10) of the Codified Ordinances of the County of Summit, the County of Summit selected Wellness IQ, Inc. ("Wellness IQ"), to provide vitality wellness services to and for the benefit of county employees at a rate and under terms and conditions equal to or more favorable than were offered to another Ohio political subdivision after that subdivision completed a competitive selection procedure; and

WHEREAS, the Board of Control, at its meeting held August 21, 2013, awarded a professional service contract with Wellness IQ, Inc., to provide vitality wellness services to and for the benefit of county employees, for a term of one year, from 11/1/13 through 10/31/14; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to confirm the award of the Board of Control of a professional service contract with Wellness IQ to provide vitality wellness services to and for the benefit of county employees for a term of one year, from 11/1/13 through 10/31/14, at a cost of \$6.50 per employee per month, plus an initial setup fee of \$5,000.00, for a total amount not to exceed \$200,000.00;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award of the Board of Control of a professional service contract with Wellness IQ, Inc.
