7 **An amended Resolution authorizing the County Executive to execute any documents**
8 **necessary to accept an award from the Summit County Department of Job and Family**
9 **Services ~~Ohio Department of Youth Services~~, as part of a funding collaborative, of a**
10 **Federal Fiscal Year 2014 Temporary Assistance to Needy Families Title XX grant, in the**
11 **amount of \$259,588.00, with no local cash match requirement, for the period 10/1/13**
12 **through 9/30/14, and appropriating \$259,588.00, for the County of Summit Court of**
13 **Common Pleas – Juvenile Division, and declaring an emergency.**

15 WHEREAS, the County of Summit Court of Common Pleas – Juvenile Division has been
16 awarded a Title XX Temporary Assistance to Needy Families (“TXX/TANF”) grant, from the
17 Executive’s Department of Job and Family Services, for the funding of a local collaborative in
18 providing services to families, in the amount of \$259,588.00, with no local cash match
19 requirement; and

21 WHEREAS, this funding is to provide Guardian Ad Litem (“GAL”) services to families
22 and, as a party in the proceedings, it is the role of the GAL to provide investigation, assessment,
23 recommendations, monitoring, and advocacy in order to assist the Court in making decisions in
24 the best interest of the children, and the Court will serve 120 youth during the grant period; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
28 execute any documents necessary to accept the award of the aforementioned TXX/TANF grant
29 from the Executive’s Department of Job and Family Services, and to appropriate these grant
30 funds;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The County Executive is hereby authorized to execute any documents necessary to accept
38 an award from the Executive’s Department of Job and Family Services, as part of a funding
39 collaborative, of a Title XX Temporary Assistance to Needy Families (“TXX/TANF”) grant, in
40 the amount of \$259,588.00, with no local cash match requirement, for the period 10/1/13 through
41 9/30/14.

20 effect and be in force at the earliest time provided by law.



28 121.22 of the Ohio Revised Code.


