An <u>amended</u> Resolution authorizing the County Executive to execute any documents necessary to accept an award from the <u>Summit County Department of Job and Family Services</u> Ohio Department of Youth Services, as part of a funding collaborative, of a Federal Fiscal Year 2014 Temporary Assistance to Needy Families Title XX grant, in the amount of \$259,588.00, with no local cash match requirement, for the period 10/1/13 through 9/30/14, and appropriating \$259,588.00, for the County of Summit Court of Common Pleas – Juvenile Division, and declaring an emergency.

WHEREAS, the County of Summit Court of Common Pleas – Juvenile Division has been awarded a Title XX Temporary Assistance to Needy Families ("TXX/TANF") grant, from the Executive's Department of Job and Family Services, for the funding of a local collaborative in providing services to families, in the amount of \$259,588.00, with no local cash match requirement; and

WHEREAS, this funding is to provide Guardian Ad Litem ("GAL") services to families and, as a party in the proceedings, it is the role of the GAL to provide investigation, assessment, recommendations, monitoring, and advocacy in order to assist the Court in making decisions in the best interest of the children, and the Court will serve 120 youth during the grant period; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to accept the award of the aforementioned TXX/TANF grant from the Executive's Department of Job and Family Services, and to appropriate these grant funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

 The County Executive is hereby authorized to execute any documents necessary to accept an award from the Executive's Department of Job and Family Services, as part of a funding collaborative, of a Title XX Temporary Assistance to Needy Families ("TXX/TANF") grant, in the amount of \$259,588.00, with no local cash match requirement, for the period 10/1/13 through 9/30/14.
