13 WHEREAS, the Board of Control, at its meeting held August 21, 2013, awarded the
14 renewal of various professional service contracts for Temporary Assistance for Needy Families
15 agreements, per attached Exhibit A, for Federal Fiscal Year 2014, for the period 10/1/13 through
16 9/30/14, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract renewals are necessary and in the best interest of the County of Summit;

29 exceed \$365,000.00, is hereby confirmed and the County Executive is hereby authorized to
30 execute such contract renewals.


