A Resolution authorizing the County Executive to execute a memorandum of understanding with the Ohio State University for the use by its Summit County Extension Service of approximately 1,861 square feet of office space located at 2525 State Road, Cuyahoga Falls, Ohio, 44224, in Council District 2, for a one-year term from 1/1/14 through 12/31/14, in the amount of \$4,722.99 per quarter, or \$18,891.96 for the term of the memorandum of understanding, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2012-032, which authorized the County Executive to execute a lease or similar agreement or memorandum of understanding with the Ohio State University for the use by its Summit County Extension Service of approximately 1,861 square feet of office space located at 2525 State Road, Cuyahoga Falls, Ohio, 44224, in Council District 2, for a two-year term from 1/1/12 through 12/31/13, in the amount of \$4,722.99 per quarter, or \$18,891.96 annually, for a total of \$37,783.92 for the term of the lease, similar agreement or memorandum of understanding; and

WHEREAS, the County and the Ohio State University executed a memorandum of understanding, which will expire on December 31, 2013; and

WHEREAS, the County and the Ohio State University Extension Service wish to enter into a new memorandum of understanding for the same purpose, at the same price, for a one-year term, from 1/1/14 through 12/31/14; and

WHEREAS, because the Ohio State University Extension Service is an agency of the State of Ohio, the approval of the Board of Control is not necessary pursuant to Section 177.17(e) of the Codified Ordinances of the County of Summit; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned memorandum with the Ohio State University is necessary and in the best interest of the County of Summit and that the Executive should be authorized to execute the same;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute a memorandum of understanding with the Ohio State University for the use by its Summit County Extension Service of approximately 1,861 square feet of office space located at 2525 State Road, Cuyahoga Falls, Ohio, 44224, in Council District 2, for a one-year term from 1/1/14 through 12/31/14, in the amount of \$4,722.99 per quarter, or \$18,891.96 for the term of the memorandum of understanding.
