A Resolution confirming an award by the Board of Control of a professional service contract with Akron Legal News, Inc., to provide publication of notices of Sheriff sales and other necessary legal notices, with funds being collected up front by the Clerk of Courts, for the period 1/1/14 through 12/31/18, with two five-year renewal options, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, the County, upon reviewing responses to a request for proposals, has determined that the proposal received by Akron Legal News is the most cost-effective provider of publication services for notices of Sheriff sales; and

WHEREAS, the Board of Control, at its meeting held October 16, 2013, awarded a professional service contract to Akron Legal News for publication of notices of Sheriff sales and other necessary legal notices pursuant to Sections 2329.26 and 2329.27 of the Ohio Revised Code, for the period 1/1/14 through 12/31/18, with two five-year renewal options; subject to confirmation by County Council; and

WHERAS, the Court of Common Pleas establishes a fee schedule which includes the cost of such notices, which cost is collected by the Clerk of Courts as part of the filing fees in each case where such notice may be necessary; and

WHEREAS, the Court of Common Pleas has, by Miscellaneous Order, approved the use of Akron Legal News for the provision of such services; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to confirm the award of the aforementioned contract.

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a professional service contract with Akron Legal News, Inc., to provide publication of notices of Sheriff sales and other necessary legal notices, with funds being collected up front by the Clerk of Courts, for the period 1/1/14 through 12/31/18, with two five-year renewal options, is hereby confirmed and the County Executive is authorized to execute such contract.

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason to immediately provide for the continued publication of notices legal notices for the Sheriff and Clerk of Courts effective 1/1/14.
