7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **Lockhart Concrete, Inc., for the Q-831 Pump Station No. 48 replacement project, in the**
9 **City of New Franklin, in Council District 7, in an amount not to exceed \$299,325.00, and**
10 **appropriating funds in an amount not to exceed \$329,257.50 for the period ending 12/31/13,**
11 **for the Executive's Department of Environmental Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held November 13, 2013, awarded a
14 construction contract with Lockhart Concrete, Inc., for the Q-831 Pump Station No. 48
15 replacement project, in the City of New Franklin, in Council District 7, subject to confirmation
16 by County Council; and

18 WHEREAS, concurrently with this Resolution, this Council has adopted a Resolution
19 approving a loan agreement with the Ohio Water Development Authority to finance the Q-831
20 Pump Station No. 48 replacement project in the amount of \$299,325.00; and

22 WHEREAS, it is necessary to appropriate these loan proceeds totaling \$299,325.00 and it
23 is also necessary to appropriate project contingency funds totaling \$29,932.50, in the event
24 unforeseen project costs are incurred; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that the contract is necessary and the appropriation of the aforementioned funds in the amount of
28 \$329,257.50 for the period ending 12/31/13 is necessary and in the best interest of the County of
29 Summit;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:
