7 **A Resolution confirming an award by the Board of Control of professional service**  
8 **contracts with Hope Homes to rehabilitate two community-based group homes for adults**

10 **amount not to exceed \$110,000.00, and adjusting appropriations in the amount of**  
11 **\$62,000.00 through 12/31/13 for the Executive's Department of Community and Economic**  
12 **Development, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held November 6, 2013, awarded  
15 professional service contracts with Hope Homes to rehabilitate two community-based group  
16 homes for adults with developmental disabilities, per attached Exhibit A, in Council District 3,  
17 subject to confirmation by County Council; and

19 WHEREAS, it is necessary to appropriate these additional funds and adjust existing  
20 appropriations in the amount of \$62,000.00 for the Home Investment Partnership Fund; and

23 that the contracts are necessary and in the best interest of the County of Summit;
