WHEREAS, this Council previously adopted Resolution No. 2015-544, which confirmed an award by the Board of Control of a purchase contract with Cavanaugh Building, Corp., for the Women's Community Based Correctional Facility Structural Repairs and Interior Renovation Project, in the City of Akron, in Council District 5, in an amount not to exceed \$182,951.00, subject to confirmation by County Council; and

WHEREAS, the contractor encountered additional tasks during the construction of the Project, requiring Change Order No. 1, in the amount of \$17,994.50 (9.84% increase); and
