8 **equipment full maintenance service at 250 Opportunity Parkway, Akron, Ohio 44304, for**

10 **Administrative Services- Physical Plants, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for a five-year HVAC
16 equipment full maintenance service at 250 Opportunity Parkway, Akron, Ohio 44304, in Council
17 District 5, for an estimated total cost not to exceed \$60,000.00; and

19 WHEREAS, a copy of the bid specifications are attached as Exhibit A; and

21 WHEREAS this Council finds and determines, after reviewing all pertinent information
22 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
23 advertise for bids for a five-year HVAC equipment full maintenance service at 250 Opportunity
24 Parkway, Akron, Ohio 44304, for an estimated cost not to exceed \$60,000.000;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

31 The County Executive is authorized to advertise for bids for a five-year HVAC full
32 maintenance service at 250 Opportunity Parkway, Akron, Ohio 44304, in Council District 5, for
33 an estimated cost not to exceed \$60,000.00.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the
39 Executive to immediately advertise for bids for the necessary five year HVAC equipment full
40 maintenance service at 250 Opportunity Parkway, Akron.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.
