SECTION 1

The award by the Board of Control of a purchase contract with Montrose Ford, Inc. for two 2017 Ford AWD marked Explorer Interceptors and one 2016 Ford FWD marked Taurus sedan, under CUE pricing, in an total amount not to exceed \$79,250.55 is hereby confirmed and the County Executive is hereby authorized to execute such purchase contract.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason to immediately replace unreliable vehicles for the Sheriff's Office in 2016.

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
