7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award of a Federal Fiscal Year 2016 Victims of Crime Act grant from the State**
9 **Ohio Attorney General's Office, for the period of 10/1/15 to 9/30/16, in the amount of**
10 **\$2,733.60, with a local cash match requirement of \$683.40, and appropriating said grant**
11 **funds, for the Prosecutor, and declaring an emergency.**

13 WHEREAS, the County of Summit Prosecutor has received an award from the State of
14 Ohio Attorney General's Office of a Federal Fiscal Year ("FFY") 2016 Victims of Crime Act
15 ("VOCA") grant, for the period 10/1/15 through 9/30/16, in an amount of \$2,733.60, with a local
16 cash match requirement of \$683.40, for a VOCA award total of \$3,417.00; and

18 WHEREAS, the local cash match requirement will be provided by the Prosecutor's
19 General Fund; and

21 WHEREAS, the grant funds allow two victim services staff members from the
22 Prosecutor's Office to attend the 2016 National Organization for Victim Assistance conference
23 in Atlanta, Georgia; and

25 WHEREAS, it is necessary to authorize the County Executive to execute any documents
26 necessary to accept the aforementioned grant from the State of Ohio Attorney General's Office
27 and to appropriate said grant funds;
