13 WHEREAS, the Board of Control, at its meeting held August 3, 2016, awarded a
14 professional service contract with Child Guidance and Family Solutions to provide prevention
15 and intervention services for preschool aged children, for a one-year term, for the period of
16 10/1/16 through 9/30/17, in an amount not to exceed \$85,000.00, subject to confirmation by
17 County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information
20 that the aforementioned professional service contract with Child Guidance and Family Solutions
21 is necessary and in the best interest of the County of Summit;

29 Guidance and Family Solutions to provide prevention and intervention services for preschool
30 aged children, for a one-year term, for the period 10/1/16 through 9/30/17, in an amount not to
31 exceed \$85,000.00, is hereby confirmed and the County Executive is hereby authorized such
32 professional service contract.
