12 WHEREAS, County Council previously adopted Resolution No. 2015-367, which  
13 authorized the County Executive to execute any documents necessary to accept an award from  
14 the State of Ohio Department of Rehabilitation and Correction of State Fiscal Year 2016 and  
15 2017 SMART Ohio Program grants for non-violent offender diversion, for the period 7/1/15  
16 through 3/30/17, in a total amount not to exceed \$1,000,000.00, with no local cash match  
17 requirement; and

19 WHEREAS, it is necessary to appropriate funds, in the amount of \$161,750.00, for  
20 development programs under the State Fiscal Year 2017 SMART Ohio Program grant, through  
21 12/31/16; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that it is necessary and in the best interest of the County of Summit to appropriate funds, in the  
25 amount of \$161,750.00, for development programs under the State Fiscal Year 2017 SMART




