7 **A Resolution authorizing the County's Department of Job and Family Services to transfer**
8 **an amount not to exceed \$700,000.00 in Title XX/TANF funds and/or Title XX Base funds**
9 **to Summit County Children Services, for the Executive's Department of Job and Family**
10 **Services, and declaring an emergency.**

11
12 WHEREAS, the County's Department of Job and Family Services ("DJFS") is the
13 recipient of certain Title XX/TANF funds, which it receives as part of its annual allocation; and

14
15 WHEREAS, DJFS anticipates receiving an allocation notice from the State of Ohio of
16 Title XX/TANF and Title XX Base funds for DJFS for the period 10/1/16 through 9/30/17; and

17
18 WHEREAS, Summit County Children Services ("SCCS") provides protective services
19 for children and emancipating out of foster care services that are eligible expenses for the use of
20 Title XX/TANF funds; and

21
22 WHEREAS, in exchange for providing such services, DJFS will transfer an amount not
23 to exceed \$700,000.00 in Title XX/TANF funds to SCCS to be used for Non-Allocated
24 Children's costs; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to authorize the transfer of an
28 amount not to exceed \$700,000.00 of Title XX/TANF funds and/or Title XX Base funds to
29 SCCS, and to authorize the Executive to execute any documents necessary to effectuate said
30 transfer;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

35 SECTION 1

37 The County Executive, through the Department of Job and Family Services, is hereby
38 authorized to transfer an amount not to exceed \$700,000.00 in Title XX/TANF funds to Summit
39 County Children Services ("SCCS") to be used for Non-Allocated Children's Services costs, and
40 the County Executive is further authorized to execute any documents necessary to effectuate said
41 transfer.

45 This Resolution is hereby declared an emergency in the interest of the health, safety and
46 welfare of the citizens of the County of Summit and for the further reason to immediately
47 authorize the transfer of said Title XX/TANF funds and/or Title XX Base funds to SCCS.
