7 **A Resolution approving and accepting a subdivision titled “The Preserve at Miller’s Farm**
8 **Subdivision Phase 3” located in Copley Township, for the Executive-Planning Commission**
9 **and the Engineer, and declaring an emergency.**

11 WHEREAS, on July 21, 2016, the Planning Commission approved the plat for the
12 subdivision titled “The Preserve at Miller’s Farm Subdivision Phase 3,” concerning a subdivision
13 in Copley Township, in Council District 5; and

15 WHEREAS, under Section 1103.07 of the Codified Ordinances of the County of Summit
16 and Section 711.041 of the Ohio Revised Code, the approval and acceptance of this Council is a
17 prerequisite for the recording of the Subdivision plat; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that the acceptance and approval of the aforementioned plat is necessary and in the best interest
21 of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that;

28 The subdivision, which shall be known as “The Preserve at Miller’s Farm Subdivision
29 Phase 3”, in Copley Township, in Council District 5, together with restrictions, covenants and
30 easements thereon, is hereby approved and accepted by the County of Summit, to be recorded by
31 the County Fiscal Officer.

35 The following performance bond furnished by Argonaut Insurance Company in the
36 amount of \$ 805,219.00, having been submitted and approved, was accepted in conjunction with
37 “The Preserve at Miller’s Farm Subdivision Phase 3.” The documents are to be retained by the
38 County Executive, who is authorized to release said bond, in part or in full, upon satisfactory
39 completion of the obligations set forth.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the citizens of the County of Summit, and for the further reason that it immediately
45 facilitates development in Copley Township, in Council District 5.

8 effect and be in force at the earliest time provided by law.


