7 **A Resolution adjusting existing appropriations, in the amount of \$30,000.00, within the**  
8 **Behavioral Health and Juvenile Justice grant, awarded by the Ohio Department of Youth**  
9 **Services, for the period 7/1/15 through 6/30/16, for the Court of Common Pleas – Juvenile**  
10 **Division, and declaring an emergency.**

12 WHEREAS, this Council previously adopted Resolution 2015-242, which authorized the  
13 County Executive to execute any documents necessary to accept the award by the Ohio  
14 Department of Youth Services of a Behavioral Health and Juvenile Justice grant, for the period  
15 of 7/1/15 through 6/30/16, in the amount of \$385,720.00, with a local cash or in-kind match of  
16 \$115,385.00, and appropriated grant funds; and

18 WHEREAS, it is necessary to adjust existing appropriations, in the amount of  
19 \$30,000.00, within the Behavioral Health and Juvenile Justice grant, awarded by the Ohio  
20 Department of Youth Services, for the period 7/1/15 through 6/30/16, in order to cover  
21 underestimated salary and benefit costs for the grant period; and

23 WHEREAS, this Council find and determines after reviewing all pertinent information,  
24 that it is necessary and in the best interest of the County to adjust existing appropriations, in the  
25 amount of \$30,000.00, within the Behavioral Health and Juvenile Justice grant, awarded by the  
26 Ohio Department of Youth Services, for the period 7/1/15 through 6/30/16 for the  
27 aforementioned reason;
