7 **A Resolution confirming an award by the Board of Control with Tyco/Simplex Grinnell,**
8 **LP., of a five-year full maintenance service contract for the fire alarm system, electronic**
9 **door control and door card access system at the Summit County Jail, at State Term**
10 **Pricing, in an amount not to exceed \$37,595.44 annually, for a total amount not to exceed**
11 **\$187,977.20, for the Executive's Department of Administrative Services- Physical Plants**
12 **Division, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held October 5, 2016, awarded a five-
15 year full maintenance service contract to Tyco/Simplex Grinnell, LP, for the fire alarm system,
16 electronic door control and door card access system at the Summit County Jail, in the City of
17 Akron, in Council District 4, at State Term Pricing, in an amount not to exceed \$37,595.44
18 annually, for a total amount not to exceed \$187,977.20, subject to confirmation by County
19 Council; and

21 WHEREAS, this Council finds and determines after reviewing all pertinent information,
22 that the aforementioned full maintenance service contract with Tyco/Simplex Grinnell LP is
23 necessary and in the best interest of the County of Summit;

25 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
26 of Ohio, that:

30 The award by the Board of Control of a five-year full maintenance service contract with
31 Tyco/Simplex Grinnell, LP, for the fire alarm system, electronic door control and door card
32 access system at the Summit County Jail, in the City of Akron, in Council District 4, at State
33 Term Pricing, in an amount not to exceed \$37,595.44 annually, for a total amount not to exceed
34 \$187,977.20, is hereby confirmed and the County Executive is hereby authorized to execute such
35 service contract.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the citizens of the County of Summit, and for the further reason to immediately
41 provide for the necessary five-year full maintenance service agreement for the fire alarm system,
42 electronic door control and door card access system at the Summit County Jail.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.




