A Resolution authorizing the County Executive to execute a grant agreement and any other documents necessary to accept an award by the Summit County Combined General Health District d.b.a. Summit County Public Health of grant funds for lead abatement for the period 10/17/16 through 7/31/19, in the amount of \$2,224,640.00, with no local cash match requirement, appropriating grant funds for 2016, and authorizing the Executive to advertise for bids for lead abatement projects, in an amount not to exceed \$2,000,000.00, for the Executive's Department of Community and Economic Development, and declaring an emergency.

WHEREAS, the U.S. Department of Housing and Urban Development ("HUD") Office of Healthy Homes and Lead Hazard Control is authorized to administer a Lead Hazard Reduction Demonstration Grant Program ("LHRDGP") under Section 1011 of the Residential Lead-Based Paint Hazard Reduction Act of 1992; and

WHEREAS, the Summit County Combined General Health District d.b.a. Summit County Public Health ("SCPH") has received Lead Based Paint Hazard Control ("LBPHC") and Healthy Homes Intervention ("HHI") program grant funding from HUD to provide lead hazard reduction rehabilitation services in partnership with the County of Summit in areas which are occupied by low income families with children under the age of six and where lead-based paint hazards have been found and require remediation in order to provide the opportunity for citizens to live and raise a family in a safe environment; and

WHEREAS, SCPH has awarded the County Executive's Department of Community and Economic Development LBPHC and HHI grant funds for the period 10/17/16 through 7/31/19, in the amount of \$2,224,640.00, with no local cash match requirement, for the County of Summit, through the Department of Community and Economic Development, to be engaged as service provider to implement the objective of lead paint abatement in units meeting the income qualifications in areas of Summit County; and

WHEREAS, it is necessary to appropriate the award of grant funds, in the amount \$2,224,640.00, for 2016; and

WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit requires this Council's authorization for the County Executive to advertise for bids; and

WHEREAS, it is necessary to authorize the Executive to advertise for bids for lead abatement projects, in an amount not to exceed \$2,000,000.00; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute a grant agreement and any other documents necessary to accept the award of the aforementioned grant funds from SCPH, to appropriate said grant funds and to authorize the Executive to advertise for bids for lead abatement projects, in an amount not to exceed \$2,000,000.00;
